## MAYOR'S **MESSAGE**

#### **MACQUARIE PARK**

I'm encouraging members of our community to provide submissions to the State Government's

Macquarie Park Transport Oriented Development (TOD) rezoning proposal, which is on public exhibition until 9 August.

This proposal – which fails to provide a clear strategy for sustaining and enhancing employment opportunities within our community – threatens to reshape the state-significant Macquarie Park Innovation District (MPID) for generations to come.

The proposed rezoning will turn the MPID, which contributes \$13.6 billion to the NSW economy and is home to 63,000 highly skilled workers and 44,000 higher education students, into a housing dormitory and data centre hub.

And it comes with no commitments or plans for the serious infrastructure upgrades and open space that will be required for a significantly increased residential population. In fact, the

government has withdrawn any funding for open space at the former Peter Board High School site and now has plans for a 58-storey residential tower there.

I'm urging the NSW Government to engage in thorough consultation with the City of Ryde and broader MPID business community so a plan can be created for the MPID that supports employment, guarantees infrastructure provision, provides for social and affordable housing, and fosters an innovation precinct that benefits all.

I'm aware of continuing community interest in the future of Ryde's vacant Argyle Centre, with calls for it to be repurposed as a youth arts recreational facility.

At Council's 23 July Ordinary Meeting it was noted that refurbishment would cost at least \$5 million, whilst recent investment in youth performing arts programs including the new facility at Lachlan's Line and upgraded facilities at North Ryde School of Arts already provide good community space and enhance opportunities for a range of activities for young people.

It was also noted that since 2011 an Aboriginal Land Claim has impacted plans to redevelop the Argyle Centre and neighbouring bowling club. Council's long-term plan is to develop the site for a mix or retail, commercial and residential uses.

Council will write to the Minister of Aboriginal Affairs NSW requesting a determination of this matter without further delay.

We will also investigate and pursue funding opportunities from State Government grants, private sector partnerships, and other relevant sources to proceed with the redevelopment of the Argyle Centre



The City of Ryde has resolved that all submissions received in relation to rezoning and development applications will be publicly accessible on request. The supply of personal information is voluntary. However if you choose to make an anonymous submission it may be given less weight (or no weight) in the overall consideration of the application. Development Applications are available for inspection electronically and without charge at the Customer Service Centre, 1 Pope Street, Ryde (within the Top Ryde Shopping Centre) between 8.30am and 5.00pm Monday to Friday (2nd Thursday of each month – 10.00am to 5.00pm).
