PART 3: TERMS AND CONDITIONS

The City of Ryde recognises that a well-cared for street contributes to the overall appeal of a suburb and appreciates the important role of residents in carrying out general care and mowing of the nature strip area outside of their property.

Due to the extensive size of the nature strip network throughout the City of Ryde and the limited resources allocated towards mowing, Council relies on residents to mow the nature strip area outside of their property. However, Council acknowledges that for some residents their personal circumstances may restrict their ability to undertake this work.

In accordance with Council's Verge and Nature Strip Maintenance Policy, the following criteria needs to be met for Council to consider the location for inclusion on Council's assisted nature strip mowing roster:

In accordance with Council's Verge and Nature Strip Maintenance Policy, the following criteria will be considered in assessing a person's eligibility for inclusion on the nature strip mowing list:

- 1. That they are a permanent resident of the City of Ryde, and occupy the property; and
- 2. Can provide a signed medical certificate confirming that there is a medical reason which prevents the applicant from being able to mow their nature strip; and
- 3. That there is no other members of the household or relatives who can mow the nature strip; and
- 4. Engaging a contractor to undertake the mowing would create a financial hardship for the applicant.

Council will respond to the applicant within 4 weeks to advice if the application has been approved by Council. If the application is approved, the nature strip will be added to Council's mowing roster for a 12-month period with staff undertaking mowing approximately every 6-8 weeks, or as determined by staff and funding availability.

At the end of the 12 months period, residents will be notified of their need to reapply if the service is still required. If no new application is received, or the resident no longer meets the eligibility criteria this service will cease, and they will be notified of the date when the service will end.
